Charitable Lead Trust: The lead trust's income payments are distributed to Manresa for a set period of years, after which the assets are transferred back to the grantor.

Easy Gifts That Anyone Can Give

Bequest: A bequest is a gift through your will or revocable trust that enables you to retain the asset during your life and provide a gift upon the death of you and/or your spouse.

Appreciated Securities (or other assets): Donate appreciated stocks, bonds or mutual funds and save on capital gains tax.

Charitable IRA Rollover: A tax-saving giving opportunity for those over 70¹/₂.

Real Estate: Donate your house, take a tax deduction and continue to live in it rent-free.

Life Insurance: Give a policy you no longer need or buy a policy making Manresa the owner and beneficiary.

Retirement Plan Assets: Naming Manresa as beneficiary to an IRA or 401K can avoid taxation, enabling the asset to pass tax-free to Manresa.
